BoCoFIRM Focus is on Forcing the County To Perform Its Statutory Duties

The court noted that:

A **county** is **not** an **"independent governmental entity** existing by reason of any inherent sovereign authority of its residents; rather, it is a political subdivision of the state, existing only for the **convenient administration of the state government**, created to **carry out the will of the state**."

quoting Board of County Comm'rs v. Love, 470 P.2d 861, 862 (1970); accord Bowen/Edwards Assocs., 830 P.2d at 1055.

Our Goals and Accomplishments

Goal #1 – Defeated the PID at the ballot box
Goal #2 – Defeated the LID in court

- * Saved taxpayers over \$72M in assessments over 15 years
- * Returned assessments with 8% interest
- * Removed liens on 10,900 properties

Goal #3 – Get roads fixed without new taxes

* Force the County to perform statutory duty to maintain subdivision roads

[CRS 43-2-111] County assigned [responsibility for] both primary and SECONDARY [ROAD] construction and MAINTENANCE.





Lawsuits Re-enforced BoCoFIRM Position

- The duty to maintain subdivision roads belongs to the county and not to those who live in the subdivisions. [Judges Lowenbach and Williams]
- The court wrote "Proper maintenance of subdivision streets and roads requires periodic resurfacing, chip and seal, and overlay work." [Judges Lowenbach and Williams]
- * **Subdivision roads are public roads** available to all who might use them [Boulder County in MTD]
- * County acknowledged it made budget decisions **knowing that subdivision roads would eventually fail** [Boulder County in MTD]
- County cannot tax subdivision property owners ONLY for subdivision roads - they are a public interest



How Bad Are Pine Brook Hills Roads?





Subdivision Road Neglect Began Long Ago






- * Roads deteriorated rapidly without treatment.
- * Funding policy for subdivision roads hidden from property owners until 2009.
- * Policy clearly violates state law
- 2009 policy revisions were "indicators" for the PID/LID funding strategy.
- Maintenance non-existent on most subdivision roads for >25 yrs.
- * County wants to pin the cost of **their neglect** of subdivisions roads on property owners.





The Road & Bridge Fund Was Raided From 1997 to 2004








Open Space Funds Include Small Portion From General Fund


General Fund Portion is Entirely Discretionary

\$4.6M/Year Available For Roads



Fairness in Road Maintenance

More Than Enough Revenue

- BoCo FIRM's contention is \$4,000,000 can be found in a \$459,000,000 budget
- * Commissioner's Unassigned General Fund Balance grew from \$39,311,612 in 2009 to \$63,603,614 in 2012
- In other words, the County collects so much revenue each year they can't spend it all and yet they still refuse to fix our roads



Lawsuit Summary

- * Oct 13 1st Amended Complaint Filed Breach of Contract
- * Dec 30 Judge Williams Granted County Motion to Dismiss
- Feb 9 2nd Amended Complaint Filed Abuse of discretion, arbitrary and unreasonable in prioritizing budget for maintenance of subdivision roads
- * Feb 13 County's Motion to Dismiss Filed
- * Apr 2 Judge Williams Granted County Motion to Dismiss citing lack of standing



We Will Appeal

May 21 - BoCoFIRM will file a Notice of Appeal to the Colorado Court of Appeals to include review of the following court decisions:

1) Dismissal of contract claims on the basis that there could be no maintenance contracts between developers of subdivisions who improved roads and dedicated them to the County and the County that accepted those roads.

- **2)** Dismissal of a mandamus claim on the grounds that it was based on contract and not, as alleged, on the County's statutory duty to maintain county roads.
- **3)** Dismissal of the claim that the County's failure to perform statutorily required road maintenance was arbitrary and unreasonable on the grounds that property owners lacked standing did not have a protected legal interest in maintenance of the roads they use for access and did not suffer an injury in fact that is not common to all county property owners.

Highway Users Tax Fund - HUTF Over \$100M in funding received

- HUTF governed by statute
- * Counties receive 63% of HUTF funds after state allocation
- Roads must be open, used, & maintained to receive allocation.
- * Boulder County claims 143 miles of maintained paved subdivision roads for HUTF purposes.
- False mileage certifications and road reports were submitted yearly since before 1990.
- County has defrauded Colorado for over 25 years.
